# c) Other Planning Matters.

<u>Cobham Manor Equestrian Centre - redevelopment and request for meeting</u>
I am writing to Thurnham Parish Council on behalf of Michelle Jarvis and Peter Sands who own the

Cobham Manor Equestrian Centre. As you will be aware, an application for the redevelopment of the site was refused by Maidstone BC earlier this year. Whilst there were 9 reasons for refusal, only reason 1 was the main reason for refusing the application with all other reasons being resolved or work being undertaken by us to resolve prior to the refusal.

Since then, we have completed pre-application discussions with MBC during the summer which were positive in terms of the layout and amount of development subject to managing the scale and height of the development. We have now begun devising a new scheme which takes a more traditional farmstead approach. In summary, there is no longer any private stables included in the proposal and the scheme seeks permission for seven dwellings. This will comprise 1 storey,1.5 storey and 2 storey buildings with the appearance of being former stables, barns and farmhouse.

As part of the preparation of a new application, we were hoping the Parish Council would like to meet with us and undertake a site visit. Would the parish council be available w/c 10<sup>th</sup> November for a site visit, preferably the 13<sup>th</sup> or 14<sup>th</sup> November? We would also attend the Parish Meeting on 17<sup>th</sup> November to present the scheme in detail.
