The Council hereby REFUSES listed building consent for the above for the following Reason(s):

(1) Due to the demolition and re-alignment of the existing brick piers, which are considered to be curtilage listed, and their incorporation into an entrance feature of suburban character, the proposed works would harm the significance of the curtilage listed piers, contrary to policies LPRSP14(B) and LPRENV1 of the Maidstone Local Plan Review (2021-2038) 2024 and paragraphs 202, 212, 213 and 215 of the National Planning Policy Framework. There are not considered to be any public benefits which would outweigh the harm.

Thornham Friars Pilgrims Way Thurnham Kent ME14 3LN

Internal and external alterations comprising of: Installation of cast iron railings to the perimeter wall; new perimeter wall with electrically operated sliding gates; conversion of a stable block into ancillary annexe accommodation; conversion of garden shed into a workshop, outdoor bar and log store; erection of a pavilion; retrospective permission for a greenhouse; erection of a detached car

barn; reinstatement of driveway with rebuilt brick piers and new gate access; new parking area; replacement timber windows to rear elevation with timber painted, leaded windows; dormer window repair to north elevation of main house, installation of secondary glazing throughout the remainder of the property; installation of extractor fans to all bathrooms and en-suites, (revised scheme to 23/501478/FULL).

# **Application Refused**

The Council hereby REFUSES Planning Permission for the above for the following Reason(s): (1) The proposed demolition and realignment of the existing curtilage listed brick piers to facilitate vehicle access and erection of associated walls and gates would harm the significance of the curtilage listed piers and be out of character with, and harmful to, the setting of grade II listed Thornham Friars, contrary to policies LPRSP14(B) and LPRENV1 of the Maidstone Local Plan Review (2021-2038) 2024 and paragraphs 202, 212, 213 and 215 of the National Planning Policy Framework. There are not considered to be any public benefits which would outweigh the harm. (2) Due to the design of the proposed new entrance arrangement (for access onto Aldington Lane) and the realignment and inclusion of the historic piers, the proposed development would harm the historic character and scenic quality of the Kent Downs National Landscape contrary to policies LPRSP9, LPRSP15 and LPRQD4 of the Maidstone Local Plan Review (2021-2038) 2024, paragraph 189 of the National Planning Policy Framework and policies SD2, SD3, SD8, SD9 and HCH1 of the Kent Downs Area of Outstanding Natural Beauty (now Kent Downs National Landscape) Management Plan.
(3) Insufficient information has been submitted to demonstrate that existing trees, which contribute towards the setting of grade II listed Thornham Friars, to the scenic quality and beauty of the Kent Downs National Landscape, and play an important role in mitigating against climate change, can be successfully retained, contrary to policies LPRSP14(A) and LPRSP15 of the Maidstone Local Plan Review (2021-2038) 2024 and paragraph 136 of the National Planning Policy Framework.

THE KENT COUNTY COUNCIL (PUBLIC BRIDLEWAYS KM82 (PART) AND KH123A (PART) THURNHAM) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2024

On 26 February 2025 the Kent County Council confirmed the above Order under Section 119 of the Highways Act 1980.

The effect of that Order as confirmed is to divert the entire width of that length of public bridleway numbered KM82 which begins at an unaffected length of bridleway KM82 at NGR TQ 8043 5587 (Point A) and travels in a northerly direction for 170 metres to NGR TQ 8046 5614 (Point B), then continues in a north northeasterly direction for 239 metres to NGR TQ 8058 5635 (Point X), then continues in a northeasterly direction for 95 metres to NGR TQ 8065 5641 (Point P), where the path terminates at its junction with public bridleway KH123A. As shown by the bold continuous line between Points A-B-X-P on the Order Plan and will add a new length of public bridleway numbered KM82 with a width of 4.0 metres which begins at the aforementioned Point A and travels in a northeasterly direction for 438 metres to NGR TQ 8068 5634 (Point C), then continues in a westerly direction for 99 metres to NGR TQ 8058 5635 (Point X), where the path terminates at its junction with public bridleway KM81. As shown by the broken line with crossbars in the intervals between Points A-C-X on the Order Plan.

Also, the entire width of that length of public bridleway numbered KH123A which begins at NGR TQ 8071 5638 (Point Q) and travels in a north westerly then south westerly direction for 70 metres to NGR TQ 8065 5641 (Point P). As shown by the bold continuous line between Points Q-P on the Order plan and will add a new length of public bridleway numbered KH123A with a width of 4.0 metres which

begins at the aforementioned Point Q, and travels in a south westerly direction for 48 metres to NGR TQ 8068 5634 (Point C), where the path terminates along the length of Public Bridleway KM82. As shown by the broken line with crossbars in the intervals between Points Q-C on the Order Plan. All directions general, all distances approximate.

It was agreed that the situation might be improved if the bollards along the A2 were extended to provide verge protection, and the Clerk was asked to liaise with Kent County Council to determine whether this matter could be added to the Highways Improvement Plan.

A discussion also took place regarding the A2 improvement plans.

Cllr Duncan reported that signage debris remained on site near Roundwell, with a road closure sign from December 2024 still in place.

### Action: Clerk to report again to Kent Highways.
