# 10. Joint Parish Group/Local Plan.

Cllr Horne reported the Graham Warren of CPRE has died, he stated that he had been helpful to local parishes on numerous occasions and would be missed.

He reported on the Local Plan and stated that this was due to go before the SPI Committee at MBC on 21<sup>st</sup> September, it was currently at Regulation 19 Consultation.

He stated that this would go before Full Council on 6<sup>th</sup> October 21 to take forward.

The Coordinating Team would attend to ask questions regarding the time scales and how views would be taken into account.

Cllr Horne reported that he had attended a Water Seminar by Zoom regarding water resources for the Southeast and he reported on this. He spoke regarding the water supply for the southeast area and reported that he had made representations to their consultation, he spoke of concerns that the water supply was not enough to serve future development.

#### 11. Saint Mary's Church.

Cllr Smith reported that the new vicar was inaugurated at Hollingbourne Church, and he attended on behalf of the Parish Council.
